RE FIRST PARA MY 111125Z. FOLLOWING IS ADVANCE COPY LSIB REPLY TO PROPOSALS SUBJECT TO CONFIRMATION WHEN SIGNED BY CHAIRMAN, LSIB.

TO CHAIRMAN USCIB.

REFERENCE IS MADE TO YOUR MEMORANDUM OF 13 MARCH REGARDING THE CONFERENCE ON FRENCH CYPHERS.

IF ITS INTERPRETATION OF ITEM 2 IS CORRECT, LSIB ACCEPTS THE PROPOSED AGENDA.

LSIB WELCOMES THE EXTENDED SCOPE OF THE CONFERENCE WHICH IS IMPLIED IN ITEMS 1, 4, AND 5 AND THAT WHICH IS BELIEVED TO BE IMPLIED

IN ITEM 2. LSIB IS AGREEABLE TO THIS ITEM IF IT MEANS NO MORE THAN CONSIDERING FRENCH INTERNAL SECURITY, AND PERHAPS THE PROSPECTS

OF ITS BEING IMPROVED, IN RELATION TO FRENCH COMMUNICATIONS SECURITY. IF HOWEVER IT IS INTENDED TO INCLUDE A FORMAL ASSESSMENT OF FRENCH

INTERNAL SECURITY, OR THE DETERMINATION OF WHAT STEPS OUGHT TO BE TAKEN TO IMPROVE IT, LSIB CONSIDERES THAT THE ITEM OVERLAPS THE WORK

OF THE PROPOSED TRIPARTITE WORKING GROUP ON FRENCH SECURITY AND GOES BEYOND THE COMPETENCE OF LSIB.

THE US DELEGATION HAS BEEN NOTED WITH PLEASURE. LSIB NOMINATES THE FOLLOWING:
